That 2018 has been a bumper show will come as no surprise to those of us able to stop and look around on the day. The long hot summer meant that by the first weekend in September for many the harvest was well and truly over, while for others the chance to visit something closer to home offered some welcome relief and change of scenery. Long before we closed the show ground Ice creams, cold drinks and bottled water had all but sold out and at its height Car Parking was extremely hard to find and we had traffic queuing back up towards Alresford.

Across the show ground we have continued to adapt and alter the general layout and this year was no exception with changes in location for the Horticultural team and a rural crafts area the most strikingly obvious changes. These trial adaptations have been designed to change the flow around the ground and to create some much needed space that will continue to flex over the forthcoming years. Personally I think they have been bold and inspired changes and I would like to thank all those involved.

As in previous years the Educational Tent and its displays were once again a real high point. Our Society was able to support a significant number of school farm visits that complimented the curriculum and enabled us to bridge the ever widening gap between agriculture and the community. 12 Schools displayed this year and we already have plans in place to replicate this again with the addition of an additional farm visit aimed at encouraging more local schools within our District to participate and the President has kindly agreed to host this at Holden Farm in late February.

Val and our team have continued the drive to cap costs and the Sponsorship and Marketing team have again attracted and secured some significant sponsorship throughout 2018. However, as we continue to scrutinise areas of expenditure we have identified that the current Membership package no longer wipes its own face and when considered in the round we collectively lose money. Rather than attempting to pare back the membership package to cover the deficit we have elected to adapt and increase the membership costs so that a modest charitable profit is made from membership.

Annual Membership will increase to £45 (Member +1) Additional Guest badges will increase to £25

And a new Annual Young Person Membership will be trialled at £15

The Trustees and I would like to thank everyone for their continued support throughout the year and on show day; and in particular I would like to thank the very active sub-committee members, the Alresford Pigs, Perins and our Young Farmers and of course Val and her close team. As a Society we have made, again, this years some significant charitable donations to local causes and contributed towards wider district events and activities. Without all your continued commitment we would simply be unable to sustain such an attractive, fun and profitable community event.

The accounts set out on the following pages show that the Society had a fantastic show in 2018 with a record number of visitors. The surplus for the year amounted to £54,716. This is after making sizable donations to other local charities. Many of these donations are made in recognition of the tremendous support and help provided by those local organisations and charities which help the show to run smoothly on the day.

This year the trustees have decided to not only increase the donations, but to make some extra donations in recognition of the successful year. These include donations to RABI and FCN – two very worthwhile farming support charities.

Gate numbers and takings have increased to a record number and now raises the bar for the future. The success of the show is also dependent on trade stand income and sponsorship. I am pleased that our sponsors have continued to support the Society during this year. Their names are listed elsewhere in this annual report.

The Society has managed the cost structure very well and has kept to the budget again. However, I believe that costs will inevitably rise next year. We are also still looking for an Education sponsor to help meet the cost of our Education programme which is only partly underwritten by the HEHAA funds received in 2016.

We have retained a surplus which has been added to the general reserves. It is important that the Society builds up reserves to cushion against future cost increases, the possibility of a less profitable show or even a cancellation. We do partly insure the possibility of a show being cancelled, but we must still make sure that we are in a strong position to recover from any future setbacks. We need sufficient reserves to stage a show following the possibility of a cancelled show one year.

Finally I would like to thank Martin & Company for preparing and reporting on the Society's statutory accounts which need to be submitted to Companies House and the Charities Commission every year.

 APOLOGIES for absence received from 21 members. There being the necessary quorum, the meeting proceeded.

2. WELCOME

The Chairman, Henry Mallory, welcomed those present and thanked everyone for attending the meeting despite such inclement weather. He reported that excellent weather on the show day complimented all of this year's Society's hard work and combined to deliver a very successful 2017 Show. However, albeit rather overshadowed by the tragic deaths of Anthony Loudon, last year's President of the Show, and Joanna Cheyney, Chief Livestock Steward for many years. Expressing on behalf of the Society our condolences to their families.

3. MINUTES

The minutes of the Annual General Meeting of the Society held on 25th January 2017 were agreed.

4. TREASURER'S REPORT

Chris Monnington, Treasurer, presented the accounts for 2017. He reported that the Society had had a good Show with increased gate numbers and takings; the mainstay of the show. He also noted the dependency of the financial success of the show on sponsorship, catering and trade income, which had also increased.

Chris reported that the Society had managed the cost structure very well and had kept to budget again, for which he thanked all involved. He noted that that costs would inevitably rise in 2018, particularly with more bought-in help to set up the show. He further reported that the education sponsor (who donated £7,500 in 2017) has decided to withdraw this support after many years of generous support. The absence of a replacement sponsor creates a significant deficit for next year's projection but the Trustees have budgeted to compensate for this.

Chris reported that charitable donations of £16,400 had been made to local charities, a similar sum as the previous year. He noted that many of these donations are made in recognition of the tremendous support and help provided by those local organisations and charities enabling the show to run smoothly on the day.

The Treasurer reported that the Society's reserve account was in good shape and sufficient funds were held to stage future Shows in the event of a less profitable year or entire cancellation. The Trustees had agreed, once again, to take out cancellation insurance to cover 50% of the costs, should it be necessary to cancel the Show.

The Treasurer thanked Martin & Company for their independent examiner's report of the Society's statutory accounts, required for submission to the Charities Commission and Companies House.

There being no further questions from the floor, the Chairman thanked Chris Monnington for his report. The accounts for the year to 31st October 2017 were approved unanimously.

5. CHAIRMAN'S REPORT

The Chairman confirmed that the 2017 Show was a 'box office year' mainly due to the excellent weather on the day of the Show. He thanked all for their continued hard work behind the scenes which contributes to the continued success of the Show.

He reported some high points of the Show: the steer that escaped into pond at the start of the show; the vintage tractor display that coincidentally also marked 100 years of Ford tractors and the fantastic livestock, equine and horticultural mini shows

He noted that the Trustees are keen to vary the format of the Show to facilitate greater public interaction as future theme across the show ground (within the constraints of Health and Safety requirements).

6. ELECTION OF OFFICERS

The Chairman thanked the retiring President, the Rt. Hon. Lord Wakeham, for his support during his year in office. He formally thanked Lord& Lady Wakeham for the superb drinks party they hosted for our volunteers and supporters. In reply Lord Wakeham stated that it had been an honour and privilege to be President and he was extremely grateful for all that he had experienced during his year as President. He stated that it had been a pleasure to host a reception for the people that turn out, year after year on behalf of the Society; they were the 'spirit' of the Show that contributed to its continuing success. He felt that everyone involved should be congratulated. He wished the Show continued success and stated that he would do all he could to assist the new President.
